



INVITATION TO BID FOR *Office Supplies CY 2017*

The *Mines and Geosciences Bureau Regional Office No. V*, through the *General Appropriation Act CY 2017*³ intends to apply the sum of *Six Hundred Sixty One Thousand Three Hundred Ninety One and 32/100 Pesos (PhP 661,391.32)* being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The *Mines and Geosciences Bureau Regional Office No. V* now invites bids for *Office Supplies*.⁴ Delivery of the Goods is required *every month for the period May to December 2017*. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules

and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from *Mines and Geosciences Bureau Regional Office No. V* and inspect the Bidding Documents at the address given below during **9:00 a.m. to 4:00 p.m., Monday to Friday**.

A complete set of Bidding Documents may be acquired by interested Bidders on **April 25 to May 02, 2017** from the address below **and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (PhP 1,000.00)** Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.}

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The *Mines and Geosciences Bureau Regional Office No. V* will hold a Pre-Bid Conference⁵ on **April 28, 2017 at 9:00AM at MGB RO V Conference Room**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **May 15, 2017 at 12:00NN**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


